TERMS & CONDITIONS

1. SCOPE OF WORK:

The job of Pest control shall include the following:

- (i) **General Pest Control/Anti Termite** which means eradication of Cockroaches, Mosquitoes, Flies, Lizards, rats, removing of beehives, fumigation of canteen store bugs and fly control services, Termite etc through permitted insecticides as per Government of India and WHO norms. The Pest control should cover all the places like spray under the tables, chairs, almirahs, on and around the pile of files, on wooden furniture, on false ceiling, on all staircases, on lift lobby, on all toilets drain ducts, on all pantry rooms, in all stores and any hidden space under the furniture and should leave no space unattended.
- (ii) **Rodent Control:** Rodent controlling should be done as per orders and instructions on the subject.
- (iii) Agencies must ensure that the pest control once done shall remain effective up to next pest control failing which it shall have to be done again without any cost. The agency should bring the required pesticides or chemicals, spray them through a spray gun or place them if they are dry cubes or carry out such chemical treatment through insecticide sprays.
- (iv) The pesticides, etc. used for pest/rodent control, should not have adverse impacts on human health.

- Validity of the contract: The period of contract shall be for a period of two years from the date of start of contract. However, the contract may be extended for a further period of two years on mutual consent. EdCIL reserves the right to terminate the contract by giving 15 days notice and without assigning any reason thereof.

4. **General Conditions:**

- The agency should have their own latest equipment for performing the disinfestations and Rodent/pest control services.
- ii) The Bidder should attach list of clients along with the details of contact person, Tel. Nos., Fax, and complete address.

4. Earnest Money Deposit (EMD):

- The bidder shall furnish an amount of Earnest Money of Rs. 5,000/- (Rupees Five Thousand only) by way of Demand Draft drawn in favour of "EdCIL (India) Limited" payable at Noida. Any bid received without EMD will be summarily rejected. The EMD will be returned interest free to the unsuccessful tenderers after three months from the closing date of the tender or one-month after the award of the contract whichever is later. - 8. The quoted rates should include the cost of pesticides and related labour and transportation charges. The chemicals/pesticides used by the agency be purchased from reputed concern and should be ISI Marked and/or WHO approved.
- 9. The rates should be mentioned in figures as well as in words exclusive of taxes and levies.
- 10. No handicapped, medically unsound or child labour shall be engaged for work by the contractor.
- 11. Contractor shall have to supply gloves and protective clothes, shoes, liveries, implement and tools, which required for carrying out the job.
- 12. Contractor shall be liable for any penalty, which may be imposed by labour court for violation of any labour laws.
- 13. The contractor shall be liable to pay minimum wages the laboures engaged by him for the work notified by the department of labour, Govt. of India, from time to time. However the Corporation will not have any liability on his part for payment on account of enhanced rates.
- 14. **Performance Security**: The successful bidder shall be required to deposit an amount equal to 10% of the contract value within 15 days of issue of letter of intent, as Performance Security. Performance security shall be submitted in the form of FDR/Demand draft drawn in favour of "EdCIL (India) Limited", payable at Noida OR by way of Bank Guarantee (from Nationalized Bank or scheduled bank) valid for two years plus 90 days.
